

## PRINCIPLE POSITION ONE:

### The Rights of Persons, Governments and the Governed

- Tenet 1:** There is a Creator.
- Tenet 2:** Unalienable rights are bestowed solely by the Creator.
- Tenet 3:** All individual persons possess the Creator's unalienable rights.
- Tenet 4:** Unalienable rights can never be diminished by the law of man.
- Tenet 5:** The first unalienable right is the right to life.
- Tenet 6:** The second unalienable right is the right to liberty (freedom).
- Tenet 7:** The third unalienable right is the right to pursue happiness.
- Tenet 8:** Men institute governments to secure tenets 5, 6 and 7.
- Tenet 9:** Government has no power except that granted it by the people.
- Tenet 10:** People may dissolve a government destructive of God-given rights.

## PRINCIPLE POSITION TWO:

### The Limitations of the Government

- Tenet 1:** Governments are not the source of the rights of free men.
- Tenet 2:** Free men grant government temporary authority to govern.
- Tenet 3:** Centralized government removed from men results in tyranny.
- Tenet 4:** Government may not exist in any form, without the consent of men.
- Tenet 5:** No government may redefine the unalienable right to life.
- Tenet 6:** Government must protect the nation's security and its borders.
- Tenet 7:** Taxation must never diminish the individual pursuits of men.
- Tenet 8:** Government is controlled by diminishing its size and duration.
- Tenet 9:** The rights granted the governed supersede the all rights of government.
- Tenet 10:** Government has no unalienable rights.

### PRINCIPLE POSITION THREE: The Power and Rights of each Person

- Tenet 1:** All men possess an individual and undiminished right to speak.
- Tenet 2:** Each person may exercise religious choice without consent.
- Tenet 3:** Religious expression in the public arena should be undiminished.
- Tenet 4:** Men may always and forever keep and bear arms.
- Tenet 5:** Free assembly shall never be restricted by law or tyranny.
- Tenet 6:** Individual power and rights shall be enforced by the rule of law.
- Tenet 7:** Each person's rights are greater than the collective rights of men.
- Tenet 8:** Unlawful search and seizure shall never be permitted.
- Tenet 9:** The opportunity of advancement and gain shall not be infringed.
- Tenet 10:** Unalienable rights shall include those unable to speak in defense.

### PRINCIPLE POSITION FOUR: The Powers and Rights of the Legislature

- Tenet 1:** No legislator may be in office without the vote of the governed.
- Tenet 2:** Legislators shall be legally prohibited from an office-in-perpetuity.
- Tenet 3:** Law shall not be enacted by the Executive and Judicial branches.
- Tenet 4:** Congress' power is temporarily granted to it by governed.
- Tenet 5:** Laws enacted by the Legislature are rescindable by the governed.
- Tenet 6:** Pending law shall be adequately posted for review by the governed.
- Tenet 7:** No law shall force the governed to engage in mandatory purchases.
- Tenet 8:** Distribution of wealth may not be mandated by legislative actions.
- Tenet 9:** Congress may not endorse any form of amnesty for illegal aliens.
- Tenet 10:** The Legislature may not enact law or budgets creating deficits.

### PRINCIPLE POSITION FIVE: The Power and Rights of the Judiciary

- Tenet 1:** Courts are obligated to provide redress to legal citizens only.
- Tenet 2:** Courts may render judgments based upon foreign law or precedent.
- Tenet 3:** The judiciary may only interpret existing law devoid of hypothetical.
- Tenet 4:** Our law shall find its basis solely in the Judeo Christian heritage.
- Tenet 5:** Capital punishment is a valid judicial remedy and social response.
- Tenet 6:** Illegal aliens shall not be provided the same protections of citizens.
- Tenet 7:** The Supreme Court shall remain the final judicial point of recourse.
- Tenet 8:** Punishment of those who inflict harm to children must be extreme.
- Tenet 9:** An unconstitutional Judiciary must be removed by the governed.
- Tenet 10:** Social trending and statistical law shall not be precedent in law.

### PRINCIPLE POSITION SIX: The Powers and Rights of the Executive

- Tenet 1:** The President is the Chief Law Enforcement Officer of the nation.
- Tenet 2:** The Executive has no power to enact an order obligatory as law.
- Tenet 3:** Irrefutable proof of US birth must be offered by the President.
- Tenet 4:** Irrefutable proof of US birth must be offered by the Vice President.
- Tenet 5:** The Executive may not appoint during Congressional recess.
- Tenet 6:** The Executive may not stipulate expenditures by Executive Order.
- Tenet 7:** The Executive shall have the power to veto any portion of a bill.
- Tenet 8:** Congressional approval shall be required for all Executive treaties.
- Tenet 9:** The Executive shall not interfere with State rights or State laws.
- Tenet 10:** The Executive shall not request foreign officers to address Congress.

### **PRINCIPLE POSITION SEVEN: The Social Obligations of the Governed**

- Tenet 1:** We defend the unalienable rights of our weakest members.
- Tenet 2:** We are obligated to alter, abolish and replace corrupt government.
- Tenet 3:** We accept the mandate to ensure the liberty of future generations.
- Tenet 4:** We are ever vigilant in the protection of our Constitution.
- Tenet 5:** We anticipate at all times the tendency of government to deceive.
- Tenet 6:** We forbid the elected to occupy positions of perpetual power.
- Tenet 7:** We desire that immigrants become citizens without violation of law.
- Tenet 8:** We insist that our national sovereignty never be compromised.
- Tenet 9:** We transmit the truths about America to succeeding generation.
- Tenet 10:** We hold the truth of our endowment by a Creator to be self-evident.
